Registered Care Manager – Home Care Services

Job Description

As a Care Manager, you will provide physical and emotional support to individuals and supervise teams of care assistants.

Duties of the job include:

- supervising a team of care assistants
- writing care plans;
- monitoring patients' vital signs, like blood pressure and heart rate;
- completing patient medication records;
- developing and leading activities for service users;
- keeping families up to date about their relatives' progress;
- training and mentoring new staff;
- attending team meetings with service managers;
- providing emergency cover.

GENERAL RESPONSIBILITIES: POLICIES AND PROCEDURES

The post-holder is required to familiarise themselves with all policies and procedures and to comply with these at all times. Employees must be aware of the responsibilities placed on them under the Health and Safety at Work Act (1974) and any subsequent relevant legislation and must follow these in full at all times including ensuring that they act in line with all agreed procedures at all times in order to maintain a safe environment for Clients, visitors and staff. Failure to comply with these policies may result in disciplinary action up to and including dismissal.

HEALTHCARE ASSOCIATED INFECTIONS (HCAIs)

All staff are required to follow the Hygiene Code and all company policies and procedures related to it and the Health Act 2006. Failure to comply with any of these may result in disciplinary action up to and including dismissal.
